



## Insurance Quote

**PREMIUM COST: 2.5% OF THE DECLARED VALUE MINIMUM PREMIUM IS \$50**

**A deductible of 3% of the total insured value will apply to all claims subject to a \$250.00 minimum deductible.**

Shipments of household goods/personal effects and personal automobiles and/or motorcycles (not more than 12 years old) are insured "all risks of physical loss or damage from any external cause.

Shipments of personal autos & motorcycles are to be insured for fair market value at the place of shipment or arrival. Claims for repairs shall be payable for fair market costs. Autos & motorcycles in excess of 1 year old must have a pre-shipment survey completed by the shipper or their representatives.

Shipments of household goods & personal effects must have a detailed itemized valued inventory. The insured value should represent actual cash value (replacement cost less depreciation) plus all transportation costs to ultimate destination.

Goods must be professionally packed.

Fragile articles are limited to 15% of the total insured value. Fragile articles include but are not limited to glass, china, marble & earthenware. A single piece of artwork or antiques are limited to \$10,000 per piece.

Loss or damage caused by moth, vermin, wear, tear & gradual deterioration are excluded.

Loss or damage to furs, or any cash, notes, stamps, deeds, tickets, travelers checks, jewelry, watches or similar valuable articles are excluded.

- COVERS FROM POINT SKY2C PICKS CARGO AND TILL DELIVERY POINT.
- GOODS MUST BE VERIFIED AT THE TIME OF DELIVERY AND IF ANY DAMAGES OR LOSS, IT MUST BE REPORTED ON DELIVERY RECEIPT.
- DAMAGES OR LOSS ARE 100% COVERED IN CASE OF BOXES AND ALL CONTENTS ARE FULLY PACKED AND SEALED BY SKY2C OR ANY OTHER PROFESSIONAL COMPANY WHO HAS BEEN PAID FOR THEIR SERVICE AND YOU HAVE DOCUMENTED PROOF FOR THEIR SERVICES RENDERED
- ANY ARTICLE THAT'S PACKED BY OWNER - AND AT DESTINATION SOME CONTENTS CLAIMED MISSING OR STOLEN, INSURANCE WILL NOT COVER SUCH CLAIMS.



- INSURANCE DOES COVER IF THE BOX OR ARTICLE INSURED HAS ANY EVIDENCE OF PILFRAGE WHICH IS DOCUMENTED BY THE SURVEOR AT THE TIME OF DESTUFFING CONTAINER AT DESTINATION OR ITS COMPLETELY MISSING
- ELECTRONICS MUST BE VERIFIED BY PACKERS IN WORKING CONDITION BEFORE PACKING OR THESE MUST BE IN COMPANIES ORIGINAL PACKING + SEAL FOR FULL COVERAGE. FOR ANY OWNER PACKED OR NON-VERIFIED ELECTRONICS, COVERAGE LIMITS TO COMPLETE LOSS OR EXTERNAL DAMAGE BUT DOES NOT COVER ANY DAMAGE DUE TO INTERNAL SHOCKS.
- FURNITURE EXCLUSIONS: CHIPPING, SCRATCH OR PAINT COMING OFF IS NOT COVERED UNDER MARINE CARGO

All items shipped must be insured, there is no provision for insuring partial shipments. Each Box must have value mentioned in front. A minimum of \$10 must be mentioned in front of each item (item means a box or a loose content individually loaded in with other boxes/items. If a lumpsum value given for insurance, an average is taken. eg: if packing list contains 100 pcs (piece means a box or loose item), and \$10,000 provided for insurance without any breakdown, than each piece will be valued @ \$100 per piece.
